acknowledge reading the terms and conditions of stay including the terms of rate.

- agree, if admitted, to remain in FEC from the period 1st October 2021 to 30 June 2022 and also ensure the payment of rent for that period. The student's who's return are scheduled for September may take possession of their rooms only if it's within the possibilities of the Hostel to do so. The month or the number of days to be paid upon arrival will be added to the first quarter.
 - agree to pay the rent (Room with 1 bed : **415€** ; Room with 2 beds : **264 €** -par student) as soon as the keys are delivered (in any case before 30 September) and **before the start of the next quarter, following the dates below**
 - ❖ for the First Quarter : during the collection of keys (before the 30th of September)
 - ❖ Second Quarter : **before the 31st of December 2021**
 - ❖ Third Quarter : **before the 31st March 2022**
- Any delay in payment of the last two terms without express consent of the Director will lead to an increase in rent to **3%**.
- agree to pay, when submitting the application, the sum of **50 €** which corresponds to the fee (for student (s) from abroad, this sum will be payable at the same time as the admission fee).
 - agree to pay **upon receive of the notification of admission, the sum of 630 €** including :
 - ❖ the earnest-money for the year 2020/2021, an amount of **230 €** (to be deducted from the rent of 1st quarter)
 - ❖ the deposit of **400 €**, refunded at the end of the stay, provided no damage is found in the room
- agree to pay on handing over the keys the rent of 1st quarter (minus the earnest-money) and the sum of **155 €** for the **Insurance and service Pack** including : WIFI Network, access to the gym, subscription to the FEC Student Association, subscription to Elan-Cahiers du FEC and room insurance. This "Insurance end Service Pack" is not refundable.
- agree to informed FEC of the arrived date before **August 13**.
 - I agree to inform the Director of my eventual withdrawal **before July 9 or 10 days after the notification of admission** if he sends the notification to me after July 10, 2018. Otherwise, the deposit and fees paid will be retained by the FEC, as compensation.

Living Terms

- A student may be immediately expelled if he or she :
 1. puts up a non authorized person in his or her room. (Barring a permission from the Director himself, it is forbidden to accommodate a person who does not live in the FEC after midnight.)
 2. regularly disturbs the other persons who live in the FEC.
 3. ingests alcoholic drinks over 15% proof in common spaces or is caught being drunk in the FEC.
 - The establishment has rooms with carpet that can be genes for those who suffer have allergies.
 - Each student is responsible for the furniture and property in his room and the building. Any damage will be subject to sanctions including dismissal from the hostel regardless of the financial coverage of repairs.
 - The FEC is approved as a University Restaurant and as such, it applies the official rate of the R.U. Payment for meals (lunch and dinner) is done through smart cards issued by the CROUS. Plates installed in the rooms are only allowed for the preparation of breakfast and hot drinks.
